## **B) BASIC RULES & REQUIREMENTS**

I understand therules applicable to this application aslisted below and that the loans will be granted in accordance with these rules:

- 1. A member must have been in the Sacco membership for more than one year.
- 2. A one off interest of 7.5 % shall be charged upfront on the loan approved
- 3. The amount applied shall not exceed 70% of the member's previous year's interest on deposits (dividends).
- 4. A member whose account is dormant or has arrears in his loan payment will not qualify for this loan.
- 5. Guarantors whose deposits were offset during the year to reduce a defaulted loan shall qualify for a lesser amount.
- 6. The loan application form must be completed and attach copy of national identity card/ passport and any other relevant supporting documents.
- 7. An application for a loan shall only be considered when the authorized loan application form is used.
- 8. The loan approved will be issued net of the insurance premium.
- 9. Loans paid through either RTGS/ EFT will incur bank charges which will be deducted from loan approved.
- 10. RTGS transfers are effected the same day. Funds transferred via EFT takes 2 to 3 working days before funds are reflected in the member's account.
- 11. This loan shall be offset against future interest on deposits or offset against deposits should the member withdraws before the year ends.
